## ORDER REGARDINGPROCEDURE FOR SUBSTITUTION OF NEW OWNERS

This matter having come before the Court upon the request of the State of New Mexico ex rel. Office of the State Engineer (State), the other parties to the adjudication through counsel of record not having objected to the proposed procedure, and the Court being fully advised in the premises,

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the following procedures will be followed in substituting new owners of previously adjudicated water rights into this adjudication:

- 1. Upon determination of a change of ownership of an adjudicated water right, the State will request the new owner to concur in a Stipulated Motion for Substitution and Waiver of Service. The request to the new owner shall include a written copy of the Motion and a copy of the filed Subfile Order. A sample of the Stipulated Motion and Waiver of Service is attached to this Order.
- 2. If the new owner concurs in the Stipulated Motion and waiver of service, the State shall file with the Court the Stipulated Motion and an Order for Substitution.

3. If the new owner does not concur in the Stipulated Motion and waiver of service, the State shall file an Opposed Motion to Substitute accompanied by a Notice of Hearing pursuant to NMRA 1-025.
