I request the budget adjustment necessary to funds appropriated in the amount of \$200,000 from the Irrigation Works Construction Fund for FY06 for Colorado River Basin metering to accommodate the services, equipment and training itemized by Mr. Williams in his December 12, 2005, memorandum.

The Colorado River Basin includes the San Juan River Basin for which active water resource management is an Agency priority. AWRM in the San Juan River Basin includes the following implementations in addition to its administrative components:

- o Metering of all ditches in the San Juan River Basin, which metering is nearing completion and requires equipment purchases and previously contracted consulting assistance to further activate and/or maintain ditch gaging stations, and vendor assistance to integrate various components of the metering equipment;
- Providing metering data on a real time basis to the public via previously purchased Sutron Corporation XConnect software, which software is currently archiving metered data and transmitting the same to the OSE website, via an outdated and inadequate personal computer, and;
- Training for the San Juan River Basin Watermaster which training includes the flow measurement workshop offered by the Bureau of Reclamation in January 2006.
