

Dear Mr. Reynolds:



It is understood that the Bureau of Reclamation had expected to get the report out by June 30th, but to do it they needed about \$180,000, the house appropriations committee approving \$132,000 and when the bill went to the Senate they raised it to the amount needed. However there was \$40,000 cut out of the bill, and the state is faced with the commitment to get the report out by the end of the year and are short to get the job done, but it is believed that if New Mexico and Colorado put up a substantial amount the Secretary of the Interior could go back to the appropriations committee with a request and secure additional funds to complete the report.

Approval was given for a grant of \$10,000 from Finance Emergency Funds for the purpose, on the condition that the State of Colorado match these funds, and upon assurance from the Bureau of Reclamation that the entire job will be finished by June 30th, 1961, funds to be withdrawn only as needed and grant to be made to the Interstate Stream Commission.

Animas-La Plata Lession

. . . With Orval Ricketts

Once upon a time a very wise man, after surveying the wars that plague mankind, suggested that nations in disagreement should select a small group of men from nations involved. These men would be locked in a room for as may months or years as necessary, and be released only when they come out with an agreement that will avent the threatened war.

Reminded that only by the force of military might can great issues be settled, he made a statement in which this idea is the chief thought:

thought:

Wars usually are settled after
the savagery of battle by men
meeting around a table. So why
not let men meet around a table
and settle it before war starts.

That of course is purely ideal-istic. It probably wouldn't work in the war threat that hangs over the world today, the possible atomic extinction of civilization itself if war is allowed be start. Maybe that is a test of the moral libre of world leadership today—man's ability to talk himself out of the possible annihilation.

But It Can Work

Be that as it may, this writer was permitted last week to sit in on the successful application of the above principle.

It seemed that citizens of La It seemed that thizers of the Plata were ready to start a little intrastate conflagration that even the impounded waters in Lake Navajo would have had a hard time to extinguish. Hard working La Plata farmers, who had formed a Walter Conservancy District to protect their nights, have been wondering for some time what was happening to their cherished Ani-mas — La Plata Reclamation Project.

And some of the rest of us old nesters also were curious to know just why this project seemed to have been lost in the building of the dam, and in controversies over how much water is to run over the hill into the Rio Gnande watershed.

Some Answers Needed Anyway the La Plata water users got on the prod because a users got on the prod because a lot of answers had not been spelled out to them. They became suspicious that old time friends here had either forgotten them or had traded off their water somehow. So a meeting was held the other night in the Avery hotel and I. J. so a meeting was need the other night in the Avery hotel, and I. J. Coury of Farmington, chairman of the state's Interstate Streams Commission, was invited to appear and answer some of the questions that were bothering our La Plata friends.

Under the chairmanship of Far-mington's Dr. G. D. Walters, the night was spent in a seminar on

the problem.

It developed that the Interstate Streams Commission some time ago had alloted a share of New Mexico's water for the Animas-La Plata lands in this state. This water has been turned over to the custody of the Secretary of In-lierior for use when the project studies are completed by the Reclamation Bureau and legislation providing the project becomes law.

Coury explained that Animas-La Plata is and always has been in the picture. The feasibility report is expected within the next two

Thus a friendly solution was arrived at through men getting together and discussing a situation in plain words. New Mexico, I am sure, has settled at least one misunderstanding among its own wa-ter users and set the stage for re-surning friendly relations with Colorado in presenting our pro-grams to Congress.

Herewith is a copy of your Application No. 2883, which was submitted by your letter of April 10, 1959, with appropriate endorsement thereon. The statute referred to in the endorsement is quoted below in full for your convenience:

"75-5-31. Federal reclamation projects - Appropriation for. - Whenever the proper officers of the United States authorized by the Pederal Reclamation Law of June 17, 1902, 38 (32) Statutes at Large, 388 or acts amendatory thereof or supplementary thereto to construct federal reclamation project works for the utilization of waters within the state, shall notify the state engineer that the United States intend to utilize certain specified waters, the waters so described and unappropriated, and not covered by applications or affidavits duly filed or permits as required by law, at the date of such notice shall not be subject to a further appropriation under the laws of the state for a period of three (3) years from the date of said notice, within which time the proper officers of the United States shall file plans for the proposed works in the office of the state engineer for his information, and no adverse claim to the use of water required in connection with such splans, in-litiated subsequent to the date of such notice, shall be recognized under the laws of the state. except as such amount of water described instruction as may be stormally released in writing by the secretary of the interportar as the of orcer of the limited States thereunico duly authorized; Provided that in case of

Dear Senator Anderson:

Your letter of March 2, 1959, addressed to Commissioner Dexheimer requests certain information on the relationship of the proposed Animas-LaPlata Project to the proposed San Juan-Chama and Navajo Indian Irrigation Projects. The information you desire follows under the same numbering as contained in your letter.

- (1) The Animas-LaPlata Project, insofar as it can be defined prior to completion of investigations, contemplates furnishing irrigation water to a total of about 86,600 acres. Of this total some 66,000 acres are in Colorado, divided about 45,900 acres new lands, 20,100 acres supplemental supply lands. In New Mexico the total acreage of 20,600 is divided 15,100 new lands, 5,500 supplemental service lands. Consideration is also being given to supplying the City of Durango, Colorado, with municipal water supply. Present thinking is this will require about 17,000 acre-feet of water per year. The Animas-LaPlata Project would obtain its water supply from the Animas River and the La Plata River.
- (2) Although final figures are not yet available as to exact water requirements, present computations indicate that the Colorado lands would be supplied by a diversion from the Animas River of about 163,000 acre-feet and from the La Plata River with about 14,000 acre-feet. The requirements for the City of Durango, as indicated above, are about 17,000 acre-feet.
- (3) There is no physical conflict between the plans proposed for the Navajo Indian Irrigation Project and San Juan-Chama Project and those for the Animas-La Plata Project. The San Juan-Chama and Navajo Indian Irrigation Projects are on the San Juan River watershed above the confluence of that river with the Animas River.
- (4) The position of some Colorado interests, as we understand it, is the fear that if the New Mexico projects on the San Juan River are constructed ahead of Animas-LaPlata and with a water right prior to that which could be obtained for the New Mexico

lands of the Animas-La Plata Project, New Mexico might ultimately decide not to develop its lands in the Animas-La Plata Project. They are concerned then that if the New Mexico lands are not included in the Animas-La Plata Project, it is possible that the remaining project might not be feasible. The concern that New Mexico might take such a position arises over the question of the magnitude of the total amount which the Upper Basin ultimately may be permitted to use of the flow of the Colorado River at Lee Ferry. They reason that if, for some cause or other, such as inadequate total water supply or requirements on the Upper Basin for servicing the Mexican Treaty, the total depletion that the Upper Basin may make would be so much less than the 7,500,000 acre-feet apportioned by the Colorado River Compact, that New Mexico would not be able to consume water beyond that required by the San Juan-Chama-Navajo Indian Irrigation Projects and certain municipal uses.

In regard to the expressed concern about feasibility of a diminished Animas-La Plata Project, our investigations have not yet reached a point where a determination can be made. The concern over the possibility that the Upper Basin may not be permitted to utilize the full amount apportioned to it under the Colorado River Compact arises from certain compact interpretations and resultant water supply studies which this Department has not considered to be acceptable.

The proposed coordinated report on the San Juan-Chama-Navajo Indian Irrigation Projects and the testimony presented to your subcommittee in the spring of 1958 were both based upon the assumption that the Upper Basin could utilize 7,500,000 acre-feet per year. Under that type analysis it can be shown that with New Mexico's share amounting to 838,000 acre-feet annually New Mexico would be able to developsall its presently foreseeable projects, utilizing waters of the San Juan River Basin, including the New Mexico portion of the Animas-La Plata Project, with about 93,000 acre-feet remaining for other potential uses.

The Duranga Herald Says:

Durango should pump water from the Animas river next the re-introduction of bills in summer in order to validate its Congress by New Mexico Sen. filing for water rights in the river, Atty. William Eakes, a member of the Southwest Colorado told members of the Congress failed to authorize League of Women Voters at a meeting Thursday night at the home of Mrs. Edward Barge.

As a supplement to its Florida river water which feeds the reservoir and filtration plant, the cty has constructed a pumping station on the Animas, and laid a line to the reservoir. It was completed last year and pump tests were made. The city has filed a plat calling for four-second-feet of water from the Animas, Eakes

Urgency of the situation is Clinton P. Anderson for authorization of the San Juan- Chama and Navajo Irrigation projects. these porjects last year, and Colorado water interests are opposing their authorization this session.

However, Eakes told the women, if these porjects were authorized, water applied to them would not leave sufficient water for the Animas-LaPlata project, and possibly not enough for Durango.

Dear Mr. Reynolds:

During my recent visit to your office you asked if in our San Juan Basin water supply analysis we gave the Animas-La Plata Project priority over uses from the San Juan River below Farmington. In effect this is true. The reason was largely to simplify an already complex study.

In determining the water available to the Animas-La Plata Project direct flow by-passed for downstream uses was limited to that required from the Animas River. Our studies may, therefore, show some capacity in Navajo Reservoir which actually provides replacement storage for the New Mexico portion of the Animas-La Plata Project. The following factors cause an accurate determination of the amount of this replacement storage difficult to make at this time.

- 1. The source of supply for uses below Farmington is both the Animas and San Juan Rivers.
- 2. The Animas-La Plata Project will be in two states involving the water laws of two states.
- 3. Ultimate status of several of the water filings in both states are still indeterminate.
- 4. The source of a large percentage of the water supply for the New Mexico portion of the Animas-La Plata project is return flows.

However, an inspection of our studies indicates that even if the 1955 date of the large Utah Construction Co. filing should eventually be perfected, the amount of replacement storage provided in Navajo Reservoir for the New Mexico portion of the Animas-La Plata Project would be negligible.

It seems to me now you asked another question about the basin water supply study, but I cannot remember what it was and I do not find anything in my notes about it. If you have other questions please let us know and we will try to answer them.

- 2. How much water has been filed on for each project in New Mexico?
- 3. What percentage of the Upper Colorado river water has been alloted New Mexico?
- 4. Of the water originally divided among the various states in the Colorado river system, what is the latest engineering report on amount available now?
- 5. Mr. Williams, engineer for the State of Colorado, seems to think it is necessary for the La Plata Conservancy District to file on right of way for canals in New Mexico. Is this necessary, and if so what is the procedure?
- 6. What effect will the Animas-La Plata project have on the land in New Mexico now under cultivation? Will this land retain the old water rights and pay only on the supplementary water?

Reference is made to your letter of April 29, 1957 concerning the proposed Animas-La Plata Project. Following are answers to your questions as numbered in your letter.

The functions of this Commission are defined generally in Chapter 75-34-3, New Mexico, Statutes, which is quoted below:

"75-34-3. GENERAL POWERS OF COMMISSION—INTERSTATE COMPACTS—EMPLOYERS—ATTORNEY GENERAL'S DUTIES. — Said commission is hereby authorized to negotiate compacts with other states to settle interstate controversies or looking toward an equitable distribution and division of waters in interstate stream systems, subject, in all cases, to final approval by the legislature of New Mexico: to match appropriations made by the Congress of the United States for investigations looking to the development of interstate streams originating in a flowing through the state of New Mexico: to investigate water supply, to develop, to conserve, to protect and to do any sud all other things necessary to protect, conserve and develop the waters and stream systems of this state, interstate or otherwise; to institute or cause to be instituted in the name of the state of New Mexico any and

all negotiations and/or legal proceedings as in its judgment are necessary to carry out the provisions of this act (75-34-1 to 75-34-3); to do all other things necessary to carry out the provisions of this act; to employ such attorneys, engineers and clerical help, as, in its judment, may be necessary to carry out the provisions of this act, and to fix their compensation and expenses; together with such other powers and duties, as may, from time to time, be given said commission by the legislature of New Mexico; the attorney general shall be the legal adviser of such commission and attorneys employed as above shall be subject to his approval and supervision and be designated as "Special Assistant Attorneys General."

Question 2. I assume that this question refers to projects receiving San Juan River water. The State of New Mexico has filed a "Notice of Intention to Appropriate" on projects and in the amounts as follows:

In addition to the above, planning of San Juan Projects have recognized water requirements for two small Indian projects, Fruitland and Hogback, which will receive water from the San Juan River, and the Pine River Extension Project which will receive a very minor amount of New Mexico's share of the Upper Colorado River Compact allocation.

Question 3. New Mexico's percentage of Upper Colorado River water is 11.25 percent.

Question 4. The most recent official engineering report is; "Report of the Yechnical Committee on use of vaters of San Juan River in New Mexico," dated January 26, 1951. In this report, New Mexico's permissible depletion of the water available to it under the Upper Coloredo River Basin Compact is listed at 838,000 acre-feet per year.

Question 5. The Bureau of Reclamation's Status Report-Animas-La Pleta Project, Colorado and New Mexico-November 1954 contemplates that the project canals in New Mexico will be located on private and public lands with a small portion on lands in the Ute Mountain Indian Reservation.

I presume that there will be a District organized in New Mexico to encompass
the entire Animas-La Plate Project, or perhaps your District would be
enlarged. At any rate, plans for the Animas-La Plata Project are still in
the preliminary stages and it is too soon to be selecting canal rights-of-way,
Final plans, designs, selection of canal routes, etc., must be determined
before rights-of-way can be acquired.

Question 6. The Bureau of Reclamation's report presents a simulated plan of operation which provides for decreed rights and also considers furnishing supplemental water to lands with these rights.

Administration of water rights under the proposed Animas-La Plata Project will present an intricate problem and is so recognized in the Bureau's report. When this Project reaches a more advanced stage of planning, local interests, State and Federal agencies will have to come to an understanding relative to the handling of decreed water rights on this project. The La Plata River Compact will govern administration of the direct flows of the La Plata River.

As to the charges for water furnished under this project, I cannot, at this time, furnish an answer.

Reference is made to the minutes of the July 22, 1955 meeting of the San Juan River, New Mexico Technical Committee which are quoted in part as follows:

Investigations -- Animas-LaPlata Project, Colorado-New Mexico

Mr. Crabtree informed the Committee that he is now conducting detail investigations for the Animas-LaPlata Project. In view of the possible indication that there may not be any water to serve the New Mexico portion, if the Navajo and San Juan-Chama Projects should be constructed to the extent indicated by the present drafts of reports, he raised the question on the advisability of extending the detail surveys to the New Mexico lands.

A meeting of representatives of the Navajo Tribal Council, Bureau of Indian Affairs, Bureau of Reclamation, and the State Engineer Office was held in Window Rock, Arizona on October 19, 1955. At this meeting the possibility of developing an all-Indian Shiprock-South San Juan project of 114,000 acres or less, instead of the proposed 137,000 acre project including both Indian and white land was considered and the Bureau of Indian Affairs agreed to undertake reconnaissance studies of this proposal. In view of this recent development it appears that there may be water available to serve

New Mexico lands in the Animas-LaPlata Project, and therefore the extension of detail surveys to cover these New Mexico lands appears justified.



NOTICE OF INITIATION OF INVESTIGATION

Name of investigation: Animas-La Plata project, Colorado-New Mexico

Location of investigation: La Plata County in southwestern Colorado and San Juan County in northwestern New Mexico, San Juan River Basin

Date investigation initiated: Preliminary investigations were started in 1936.

Detailed investigations for authorizing report to be resumed July 1955.

Probable date of completion: 1960.

- 1. Scope of proposed investigation.—Investigations to date have shown the La Plata Division to be unjustified as an initial development, and that it is necessary to consider the over-all plan for diversion of Animas River water to the La Plata River basin in order to obtain economic justification. The tentative plan involves regulation at the Teft site on Animas River, a canal diversion to the La Plata River with re-regulation of part of the imported flows and the excess flood flows of La Plata River at the offstream Hay Gulch site. Available flows in the La Plata River farther downstream would be diverted to the offstream Meadows site for use on new lands north of Fruitland, New Mexico. The proposed investigation is to refine the project plan and complete an authorizing report.
- 2. Nature of problems involved.—High costs and numerous construction problems are associated with the regulation of Animas River water and its diversion to the La Plata River basin. All potential reservoir sites are comparatively costly and may involve railroad relocations or other special problems. Rough mountainous terrain must be traversed to cross the divide between the upper Animas and La Plata River drainages. Clearing costs for a portion of the new land are expected to be comparatively high, but the land is generally a very good quality. Possibilities for enlarging the project to serve more land in New Mexico involve consideration of potential competitive uses of New Mexico's allotment of Colorado River water.
- 3. Prospective solutions which should be explored.—Cost of storage in Teft Reservoir as compared to alternative sites will require very accurate analysis and will be the most significant item in determining feasibility and scale of development. A detailed land classification will be made to eliminate lands which cannot be served economically. Further studies of potential power developments which might improve the project will be made.
- 4. Participation by local, State, and Federal agencies.--It would be appreciated if interested agencies would forward within 30 days an expression of their interest in the proposed project, and a statement of pertinent data they may have or know of that can be made available for use in the investigation, together with comments and suggestions they may care to make.



Dear Mr. Erickson:

Thank you for your letter of December 21, 1954, and for your service in distributing our status report of November 1954 on the Animas-La Plata project.

Our report may have conveyed an erroneous impression of intention with respect to the power right of the Basin Light and Power Company. It is not planned that the right be taken without due process or without just compensation. By assuming that the 205-second-foot power right could be acquired for project use we were able to tentatively formulate a larger and better project plan than otherwise would have been possible. The project plan as presented in the status report was set up only for preliminary consideration. Modification of it in more detailed studies may be necessary if the required land and water rights cannot be acquired or for various other reasons. Certain modifications, however, might make the plan infeasible.

Since project use of the power water would result in greater benefits, it is not improbable that a basis will be found for an agreement subjugating the power right to the project that will be beneficial to all concerned.

In view of the serious effect on the Animas-La Plata project plan of fully supplying the power right, it seems that the matter should be further explored along with other phases of the project.

I would appreciate your views on this suggestion.

Dear Mr. Larson:

This will acknowledge receipt of eight additional copies of the Animas-LaPlata Status Report which you transmitted to me under date of December 1, 1954. We are making the necessary distribution to the local interested parties.

We greatly appreciate the effort you have made to make this report available to us at this time. It will be very helpful. The report is well prepared and Mr. Crabtree and the rest of your staff is to be congratulated.

So far I have only one suggestion to make. On page 15 under the topic, Water Rights - Animas River, there is a discussion of the power right of the Basin Light & Power Company at Farmington. In that discussion it is stated that, 'rough studies indicate that the water involved in these rights would produce far greater National benefits if it were used on the Animas-LaPlata project than if it were used to generate power through the low head plants. We cannot let that statement stand for two reasons:

l. Whatever right the Basin Light & Power Company may have to that water is a vested property right. It cannot be taken away from them under the laws of New Mexico, regardless of National or any other benefits. I have had no indication that the Basin Light & Power Company intends to sell, release or transfer that right. On the contrary I have some indication that they are not interested in relinquishing such right. Furthermore, timer the laws of New Mexico that right remains for a particular purpose until there is outright abandonment, which may be accomplished by a declaration of the owner of the right, or forfeiture

through four years of nonuse, or a transfer to some other type or place of use through regular procedures prescribed by law.

2. The argument of confiscation of water rights because of higher use in other localities, is one that the lower basin States would very much like to impose upon the Upper Basin. I feel that we cannot allow that argument to creep into any situation regarding our water rights regardless of how minor the case may be. As you know, we have always maintained in the Upper Basin that, regardless of kinds or types of use, if we are entitled to that use the right shall never be relinquished without due process. The argument is a subtle one: If we succumb to it we lose one of the Freedoms that has made our country great.

I would appreciate having that statement in the report revised.



Two copies of our report on the Animas-La Plata project, transmitted with letter of November 26, 1954, should be corrected with ink as noted below:

- Page 28 Heading for left side of table should be Animas River instead of La Plata River. Last two columns should be under heading La Plata River.
- Page 32 Last line of first table should read:

- Page 42 Strike the last sentence of the fourth paragraph.
